TCWES PTO – MEETING AGENDA

The October 7th PTO Board meeting was called to order at 7:05pm by Frank Quick, President. In attendance from the Board were: Marina Sunkel, Nicole Ratner, Jennifer Ludlow, Brian Howells and Scot Crockett. Absent was Sarah Berget. Guests in attendance are noted in separate file based on zoom attendance. We had a total of 13 attending.

I. PTO Updates

a. 20-21 Budget Vote (SB/MS)

President Frank Quick presented the draft annual budget. He noted that this will be updated quarterly to reflect how we are doing and noted that due to the pandemic much has changed in this year for our fundraising efforts.

Motion to approve the 2020-2021 fiscal year's budget as is with no changes was made by Nicole Ratner and seconded by Scot Crockett. Motion passed unanimously.

b. Spirit Wear (FQ)

Current spirit wear is up for sale through Oct. 15th with two logo options. Thanks to Katie Delco for working on this for us this year. Other items we will be working on with local vendors include masks, tumblers and mouse pads. We hope to have those open in November.

c. Spirit Nights (BH)

Brian Howells was able to report to the group that we are working on 2 spirit nights per/month. This month we have Chipotle set for the 10th from 4-8pm earning 33% and Fosters Grill on the 21st. In addition Papa John's has agreed to do a year round fundraiser on Tuesday nights. TCWES will receive 40% discount + 10% will go back to the school every Tuesday until the end of the school year!

d. Emails (NR)

Nicole Ratner, Secretary made note to check spam filter for our new emails that are going to parents. Dr. Buchheit is still sending on our behalf however, we are working to communicate directly with parents as well. Anyone who has supported the school in the past or purchased or been a member is on the list and can subscribe or unsubscribe at anytime. Typically emails are sent monthly unless we have additional events occurring.

e. Committees

A google link was sent to all who attended the first meeting for volunteering for the various committees. We have added a school supply committee to help with the supply kits fundraiser and golf tournament to prep for next year's as soon as possible.
